Demonstrated expertise in two or more of the following areas: cloud computing security, security policy/risk assessment, digital forensics, database security &amp; auditing, operating system security, software security, client/server security and secure electronic commerce</li><li>3. Evidence of teaching effectiveness or potential</li><li>4. Evidence of research activities</li><li>5.
