

IFO FACULTY NOTICE OF VACANCY Assistant Professor of Management Information Systems College of Management TYPE OF APPOINTMENT: Full-time, Probationary (Tenure-Track)

Metro State University, a member of the Minnesota State Colleges and Universities System, is seeking to hire an Assistant Professor of Management Information Systems. This is a full-time probationary position within the Department of Management Information Systems and will start on August 15, 2024.

We are the urban, public, comprehensive university in the Minneapolis-St. Paul metropolitan area where the faculty, staff, and students of Metro State will reflect the area's rich diversity, build a culturally competent and anti-racist learning community, and demonstrate an unwavering commitment to civic engagement.

Metro State University provides an excellent, inclusive, and engaging education to eliminate opportunity gaps and empower our students to change the world their way, pursing and applying knowledge to create a better future for our communities. The university offers programs leading to baccalaureate, masters, and applied doctoral degrees. Responsibilities

Faculty members are expected to:

- Provide evidence of continuing preparation and study.
- Contribute to student growth and development through advising and assistance.
- Engage in service to the university and community.

 Demonstrate a commitment to serving a diverse student body by delivering a student-centered education and using approaches that support equitable outcomes for all students.

Minimum Qualifications: (Quantifiable and/or years of experience on the application materials can be pre-screened by HR at the request of the Search Committee. The other minimum skills necessary to do the job should be screened by the Search Committee through phone, campus, and hiring supervisor interviews and references.)

- A completed terminal degree from a regionally accredited institution in Management
 Information Systems or a related field, or a completed terminal degree with graduate-level
 coursework in Information Assurance or Information Security. ABDs with expected completion
 by August 15, 2024, will also be considered.
- Demonstrated ability to teach Information Assurance and Information Security courses effectively to a diverse, contemporary student population and contribute to meaningful assessment of student learning.
- Demonstrated potential for success in teaching and professional service activities.
- A plan for scholarly activity, creative achievement, and/or research in the specified discipline(s), or related disciplines.
- Effective communication skills (written and verbal) to communicate with a variety of persons and groups.
- Demonstrated ability to work collaboratively in an institution with a culturally, economically, and linguistically diverse workforce and student population.
- Demonstrated ability and desire to work collegially with faculty and staff from diverse cultural backgrounds.

Preferred Qualifications: (These are typically soft skills that are preferred, but not essential to do the job and will be screened by the Search Committee through phone and on-campus interviews/presentations, and references – hard to screen "off paper credentials".

- Professional experience with information security.
- CISA, CISSP, or similar certification.
- Demonstrated effective teaching at a post-secondary level.
- Experience developing course curricula at a post-secondary institution.
- Demonstrated contributions to assessment of student learning at a postsecondary institution.
- Professional development and/or expertise in culturally responsive pedagogy, anti-racist pedagogy, and/or universal design.

• Experience as an academic advisor for students at post-secondary institution.
